

**KENAI PENINSULA BOROUGH  
NOTICE OF OFFICES TO BE FILLED**

The regular election for the Kenai Peninsula Borough will be held October 4, 2011. Declarations of Candidacy may be filed with the Borough Clerk's Office, 144 N. Binkley, Soldotna, or the Borough Satellite Offices in Homer or Seward, from **8:00 a.m., August 1, 2011, through 4:00 p.m., August 15, 2011**, for the following seats:

**BOROUGH MAYOR**

One to be elected for a 3-year term

**BOROUGH ASSEMBLY**

One to be elected for a 3-year term from District 2 (Kenai)  
One to be elected for a 3-year term from District 5 (Sterling)  
One to be elected for a 3-year term from District 8 (Homer)

**SCHOOL BOARD**

One to be elected for a 3-year term from District 3 (Nikiski)  
One to be elected for a 3-year term from District 4 (Soldotna)  
One to be elected for a 3-year term from District 7 (Central)

**SERVICE AREA BOARDS**

Anchor Point Fire Service Area Board – Four to be elected by the voters residing in the service area – Seats A & E for 3-year terms, Seat B for a 2-year term and Seat D for a 1-year term.

Bear Creek Fire Service Area Board – Three to be elected by the voters residing in the service area - Seats A and B for 2-year terms and Seat E for a 3-year term.

Central Kenai Peninsula Hospital Service Area Board – Three to be elected by the voters residing in the service area - Seat A for a 1-year term and Seats B and C for 3-year terms.

Joint Operations Board for the Central Peninsula Emergency Medical Service Area and the Central Emergency Service Area – Three to be elected by the voters residing in the service area - Seat B for a 2-year term; Seat C for a 1-year term and Seat E for a 3-year term.

Kachemak Emergency Service Area Board - One to be elected by the voters residing in the service area – Seat A for 3-year term.

Lowell Point Emergency Service Area Board - Three to be elected by the voters residing in the service area - Seats B and E for 2-year terms and Seat C for a 3-year term.

Nikiski Fire Service Area Board - Three to be elected by the voters residing in the service area - Seat A for a 2-year term and Seats D and E for a 3-year term.

Nikiski Senior Service Area Board - Two to be elected by the voters residing in the service area - Seats D and E for 3-year terms.

North Peninsula Recreation Service Area Board - Three to be elected by the voters residing in the service area – Seats A and B for 2-year terms and Seat E for 3-year term.

Seward-Bear Creek Flood Service Area Board - Five to be elected by the voters residing in the service area – Seats A and D for 3-year terms, Seats C and E for 1-year terms and Seat C for a 2-year term. *[Note: Seats A, B, C & F are designated for residents of the City of Seward. Seats D, E and G are designated for residents of the service area outside the Seward city limits.]*

South Kenai Peninsula Hospital Service Area Board - Five to be elected by the voters residing in the service area - Seat C for a 1-year term, Seats D, E and F for 3-year terms and Seat G for a 2-year term.

**QUALIFICATIONS**

A qualified voter who has resided within the assembly or school district for 180 days may have his/her name placed on the ballot for borough assembly or school board in that district. A qualified voter who has resided within the service area for 180 days may have his/her name placed on the ballot for a service area board seat.

A Public Official Financial Disclosure Statement must be filed with the Borough Clerk at the time of filing a Declaration of Candidacy for assembly or school board. Candidates for service area offices are not required to file a Public Official Financial Disclosure Statement. All candidates for public office must file the required campaign disclosure statements with the Alaska Public Offices Commission. These forms will be provided to candidates by the Borough Clerk. Candidates must be present or available via fax to sign and date campaign exemption statements.

Declaration of Candidacy packets may be obtained at the Borough Clerk's Office, 144 N. Binkley, Soldotna. Forms are also available by mail, fax, or at the website listed below. Packets will also be available at the Borough Satellite Office in Seward and the Borough Satellite Building in Homer. The first day to file for offices to be filled at the October 4, 2011 regular election is **August 1, 2011**. Filing closes at **4:30 p.m., August 15, 2011**.

The Borough Clerk's Office is open from 8:00 a.m. to 5:00 p.m., Monday through Friday; the Homer Satellite Office is open from 8:00 a.m. to 5:00 p.m., Monday through Friday and the Seward Satellite Office is open from 10:00 a.m. to 3:00 p.m., Monday through Friday.
