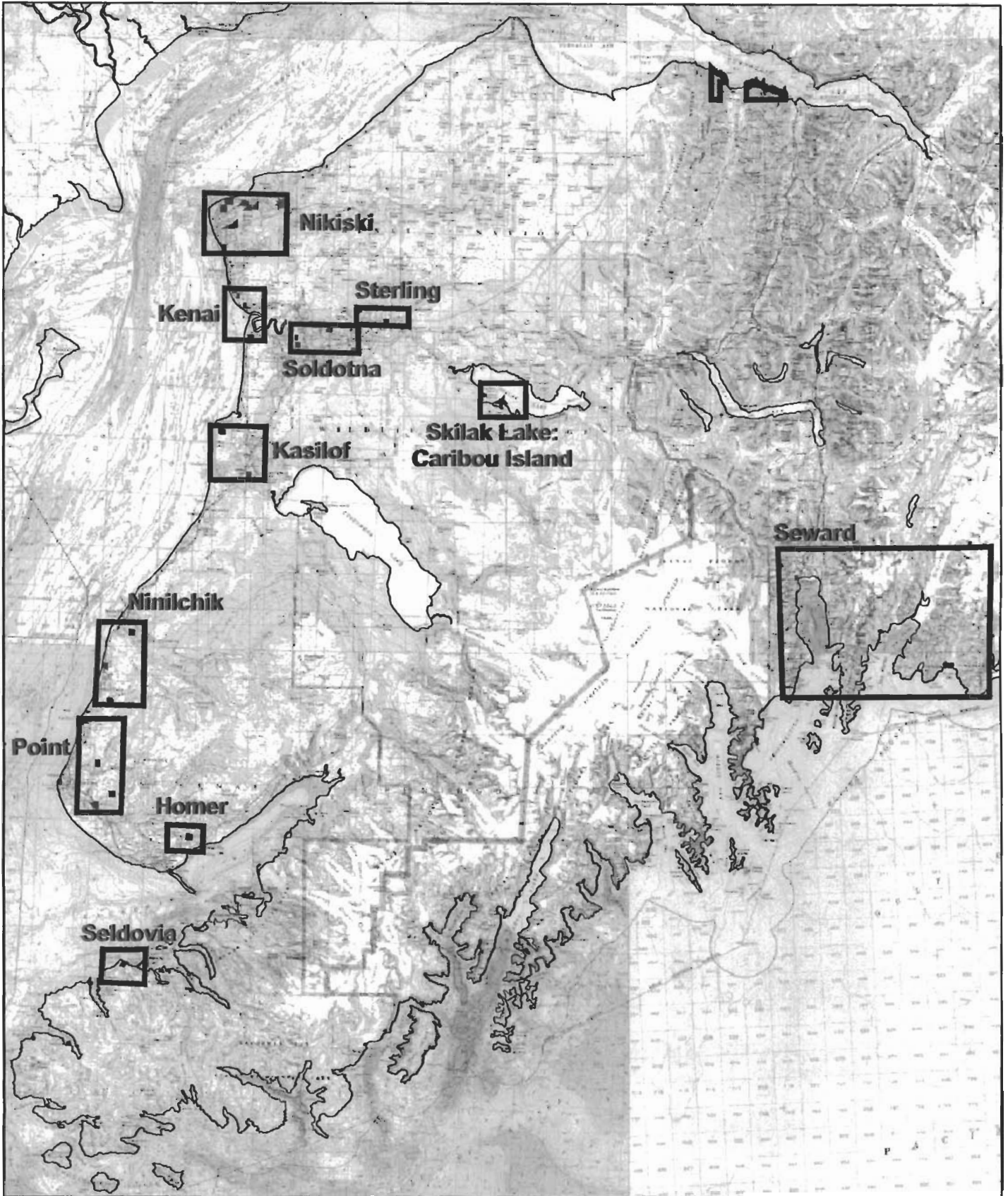

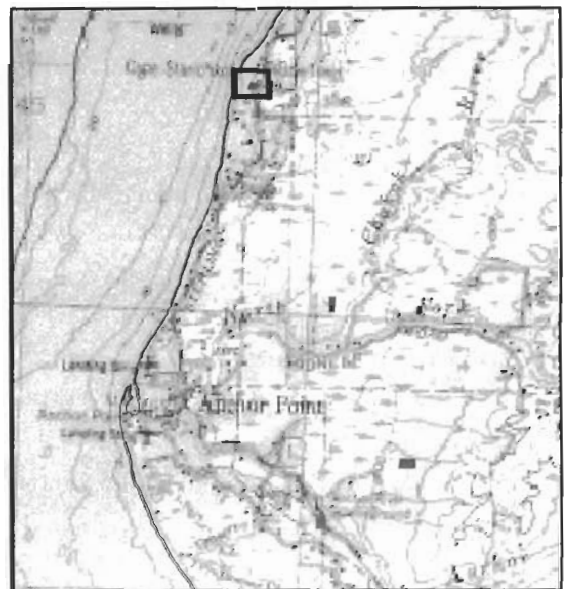
Ninilchik Area

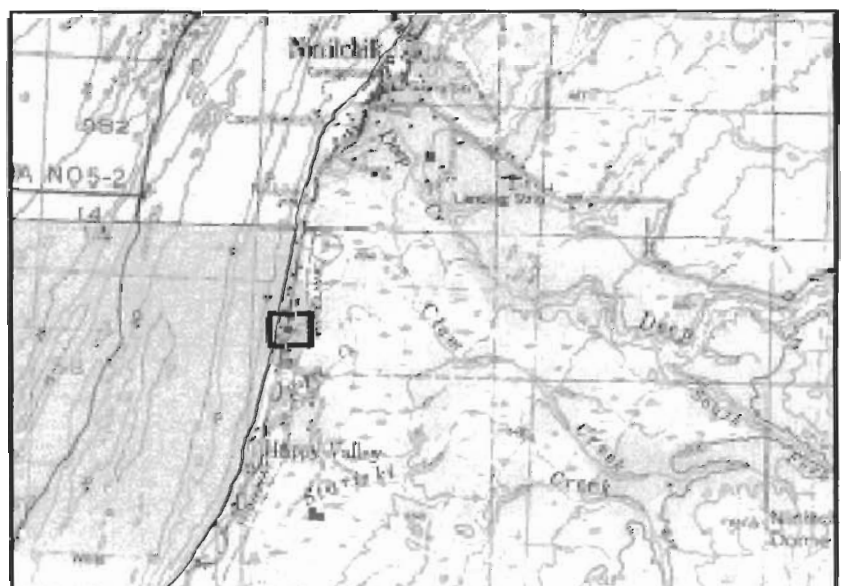
Anchor Point Area

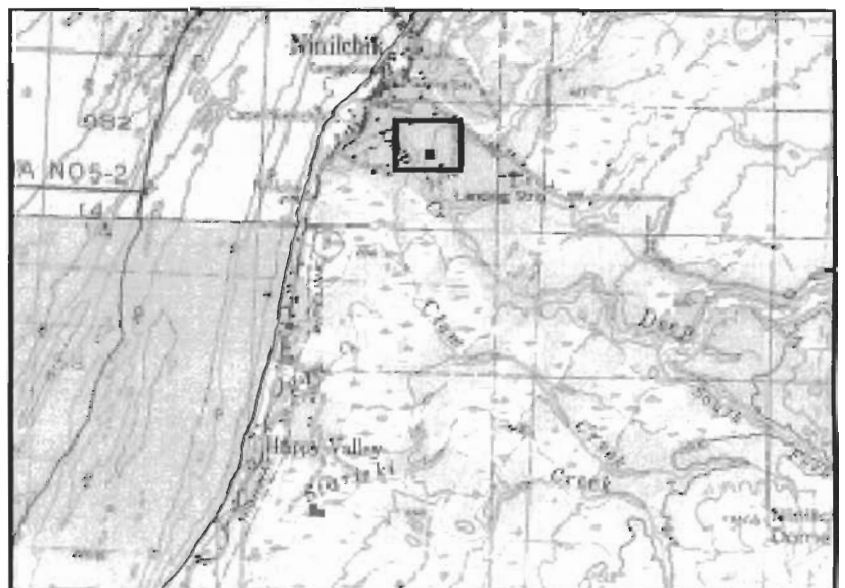


Ninilchik Area

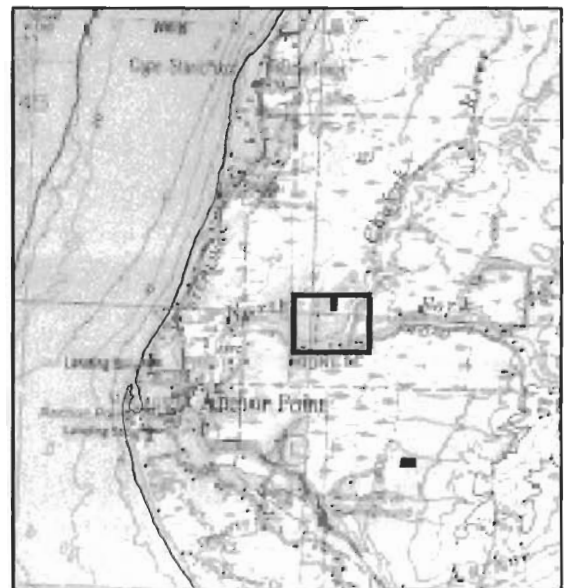

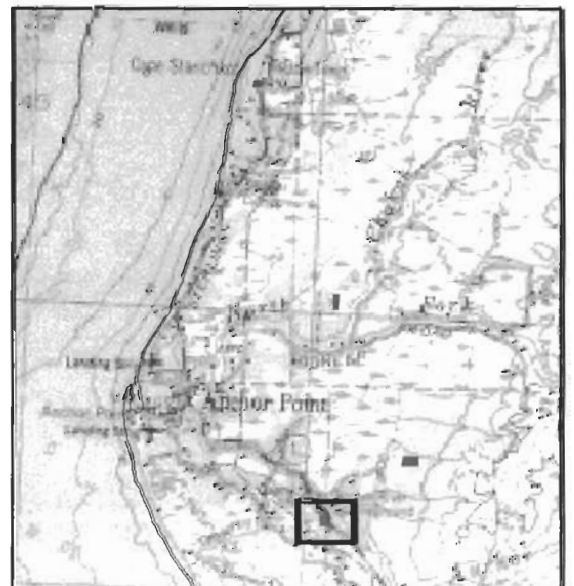
Anchor Point Area
