ORDINANCE NO. 70

AN ORDINANCE ENTITLED: AN ORDINANCE SETTING FORTH THE

PROCEDURE FOR FILLING VACANCIES IN THE ASSEMBLY; REPRESENTATIONS FROM THE AREA OUTSIDE FIRST CLASS

CITIES.

BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. Title 5 of the Kenai Peninsula Borough Code of Ordinances is amended by adding a new chapter including Sections 05.11.05 to 05.11.30, to read as follows:

Section 05.11.05. Resignation from the Assembly. Any assemblyman elected from the area outside first class cities who intends to resign from the assembly shall, whenever possible, so indicate in writing to the assembly clerk at least 30 days prior to the date of the contemplated resignation. The resignation shall be effective on the date designated in the notice, unless the assembly shall otherwise provide.

Section 05.11.10. Notice of Nomination. Upon the receipt of intent to resign as provided in Section 05.11.05 or upon the discovery of the existence of a vacancy in the representation outside first class cities, whichever is earlier, the assembly clerk with the advice of the chairman and borough attorney shall prepare a notice of nomination.

Section 05.11.15. Form. The notice of nomination shall be approved by the assembly and shall contain: A statement that a vacancy has occurred, specifying the assembly seat for which nominations will be accepted; the procedure for the petition of nomination of assembly candidates from outside the first class cities; the qualifications for borough assemblymen, and for those who may sign the nominating petition; the place for the submission of petitions which shall be the office of the clerk of the assembly; and the deadline for their submission which shall be the 14th day from the date of first posting; and any further information deemed appropriate by the assembly.

Section 05.11.20. Posting and Publication. The assembly clerk shall cause a copy of the notice of nomination to be posted in two conspicuous places in each precinct in the Borough and shall cause the notice to be published at least once in a newspaper or newspapers of general circulation in the Borough. Publication shall occur no later than three days after the day of first posting. Proff of proper publication and posting shall be obtained and submitted to the assembly by the assembly clerk at the expiration of the deadline for the submission of petitions, or as soon thereafter as practicable.

Section 05.11.25. Selection by Assemblymen Representing Areas Outside First Class Cities. Upon the expiration of the deadline for the submission of petitions, the assemblymen representing the area outside first class cities shall meet separately and recommend from the list of nominees certified to them by the clerk of the assembly one or more persons who in their opinion would best represent the constituency of the resigning assemblyman.

Section 05.11.30. Selection by the Assembly. Upon submission of the nominees selected by the assemblymen representing areas outside first class cities, the assembly as a whole shall meet, consider the recommendations of the non-city assemblymen and select a qualified acting assemblyman who shall serve the unexpired portion of the vacant seat in accordance with the provisions of AS 07.30.070.(3)

Section 2. This ordinance becomes effective immediately upon its passage and approval according to law.
