KENAI PENINSULA BOROUGH

ORDINANCE 74-2

AN ORDINANCE ESTABLISHING COMPENSATION AND AMENDING THE
EXPENSE ALLOWANCE FOR ASSEMBLYMEN.

WHEREAS, Assemblymen of the Kenai Peninsula Borough are
presently serving without compensation therefor; and

WHEREAS, Assemblymen in the normal attendance to the duties
of their office must spend a great deal of time, not only in attendance
at meetings, but also in study and preparation therefor; and

WHEREAS, additional duties devolve upon the President of
the Assembly because of the necessity to confer with the Clerk of the
Assembly and the Mayor of the Borough in regard to the agenda and
other matters inherent in the office; and

WHEREAS, Assemblymen are sometimes directed or authorized
by the Assembly to perform duties or to attend meetings (not including
assembly meetings and meetings of special committees for which they are
reimbursed for travel expense and per diem expenses) in order to give
testimony or otherwise advance the interests of the borough;

NOW THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF
THE KENAI PENINSULA BOROUGH:

Section 1. Sec. 05.10.015(a) of the Kenai Peninsula
Borough Code of Ordinances is amended to read:

"Sec. 05.10.015. (a) Compensation of Assemblymen.
Assemblymen shall be paid monthly compensation in

the amount of \$200.00. The President of the Assembly shall be paid an additional amount of \$50.00 per month because of the additional time required to attend to the duties of that office. That the compensation set herein is based on the cost of living statistics which are expected to be applicable for setting of salaries for employees of the Kenai Peninsula Borough for Fiscal Year 1976-1977, and in order to assure the same level of compensation, will be adjusted for each fiscal year thereafter by application of the percentage of change in the cost of living which is determined to be applicable for the adjustment of salaries of employees of the Kenai Peninsula Borough.

Section 2. Sec. 05.10.015(b) of the Kenai Peninsula Borough Code of Ordinances is amended to read:

"Sec. 05.10.015(b). In addition to per diem allowance and travel expense provided in subsection (c) hereafter, Assemblymen shall be reimbursed for any other expenses properly incurred on borough business and authorized by the Assembly, if vouchers therefor (supported by adequate documentation) are filed with the Borough Clerk and approved by the Borough Mayor."

Section 3. This ordinance shall become effective on November 1, 1976.
