KENAI PENINSULA BOROUGH  
ORDINANCE 74-10

AN ORDINANCE APPROVING TRANSFER TO THE KENAI PENINSULA BOROUGH  
OF THE SOLID WASTE DISPOSAL POWERS OF THE CITIES OF SOLDOTNA,  
KENAI, HOMER AND SEWARD

WHEREAS, Chapter 14.10 of the Kenai Peninsula Borough  
Ordinances provides for the selection and procurement of  
garbage and solid waste disposal sites pursuant to authority  
contained in AS 29.48.020(5) and AS 29.48.033(a); and

WHEREAS, Ordinance No. 49 of the City of Soldotna,  
Ordinance No. 233-73 of the City of Kenai, Ordinance No. 73-11  
of the City of Homer and Ordinance No. 398 of the City of  
Seward provide for the transfer of the garbage and solid  
waste disposal powers of the City of Soldotna, the City of  
Kenai, the City of Homer and the City of Seward to the Kenai  
Peninsula Borough pursuant to AS 29.33.260; now therefore

BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA  
BOROUGH:


Section 1: The transfer of solid waste disposal powers  
by the City of Soldotna, the City of Kenai,  
the City of Homer and the City of Seward to  
the Kenai Peninsula Borough are approved by  
the Kenai Peninsula Borough insofar as and  
to the extent that said power is exercised  
by the borough in the area outside cities  
pursuant to Chapter 14.10 of the Ordinances  
of the Kenai Peninsula Borough and any amend-  
ment thereto.

Section 2: The Mayor is hereby authorized and directed  
to provide for the orderly and efficient  
transfer of said powers and to execute the  
necessary documents pursuant to Chapter 14.10  
of Kenai Peninsula Borough Code of Ordinances  
to accomplish the purpose of this ordinance,  
containing additional provisions deemed nec-  
essary in the interest of the Kenai Peninsula  
Borough.


Section 3: This ordinance takes effect on July 1, 1974.
