ORDINANCE 74-29

AN ORDINANCE MAKING A FINDING OF AN EMERGENCY AND MAKING A SUPPLEMENTAL APPROPRIATION TO THE SOUTH KENAI PENINSULA HOSPITAL SERVICE AREA TO BE ADVANCED FROM THE CENTRAL TREASURY OF THE KENAI PENINSULA BOROUGH AND TO BE REPAID FROM LEVIES AND REVENUES OR OTHER FUNDS OF THE SOUTH KENAI PENINSULA HOSPITAL SERVICE AREA

WHEREAS, a summary judgment has been entered by the superior court in Kachemak City, et al, vs. Kenai Peninsula Borough, et al upholding the constitutionality and legality of the South Kenai Peninsula Hospital Service Area; and

WHEREAS, an appeal to the Supreme Court from said summary judgment may be filed therein; and

WHEREAS, an emergency exists because it is necessary to provide additional funding for continuation of work of the architect in designing the new hospital for the South Kenai Peninsula Hospital Service Area in order to meet the deadlines necessary for letting a contract for its construction in order to preserve the funding which has been secured therefor; and

WHEREAS, an additional supplemental appropriation in the total amount of \$80,000 to the said service area has been requested to make payment of expenses incurred or to be incurred for architectural services to continue preparation of plans for the new hospital project for bidding; and

WHEREAS, these expenses were not anticipated in the budget for the current year, but said funds can be repaid either from grants and loans for hospital construction from the State of Alaska or the United States or from levy and revenues to be secured from the South Kenai Peninsula Hospital Service Area during the 1974-1975 fiscal year; Now Therefore,

BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1: The assembly hereby finds that an emergency exists

Section 2: The sum of \$80,000 is hereby appropriated to the South Kenai Peninsula Hospital Service Area for expense payments to be advanced from the Central Treasury of the Kenai Peninsula Borough and to be repaid from levies and revenues or other funds of the South Kenai Peninsula Hospital Service Area received during fiscal year 1974-1975.
