ORDINANCE 74-30

AN ORDINANCE DISSOLVING THE SOUTH KENAI PENINSULA HOSPITAL SERVICE AREA AND PROVIDING FOR AN EFFECTIVE DATE AS TO CESSATION OF OPERATION AND FURTHER EXPENDITURES AFTER RATIFICATION BY THE VOTERS OF SAID SERVICE AREA AND FOR ALL OTHER PURPOSES AFTER ALL LEGITIMATE DEBTS OF SAID SERVICE AREA HAVE BEEN PAID.

WHEREAS, pursuant to AS 29.28.080 the Borough Clerk presented to the Assembly of the Kenai Peninsula Borough on May 21, 1973, a sufficient petition from residents of the South Kenai Peninsula Hospital Service Area requesting dissolution of said service area; and

WHEREAS, the Assembly of the Kenai Peninsula Borough believes that it is imperative for the welfare of the South Kenai Peninsula Hospital Service Area and its residents that this matter be placed before the electorate of said service area for a vote at the earliest possible time; Now Therefore,

BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1: Chapter 20 of Title 27 of the Kenai Peninsula Borough Code of Ordinances, as enacted by Ordinance No. 69-4 and Ordinance 73-33 of the Kenai Peninsula Borough is hereby repealed and the South Kenai Peninsula Hospital Service Area is hereby dissolved.

Section 2: This ordinance shall be placed before the electorate of the South Kenai Peninsula Hospital Service Area for ratification at a special election to be set by resolution of the Assembly of the Kenai Peninsula Borough.

Section 3: Dissolution of the South Kenai Peninsula Hospital Service Area, insofar as cessation of operation or any further expenditures are
