ORDINANCE No. 74-56

AN ORDINANCE AMENDING SECTION 1.05.05 OF THE CODE OF ORDINANCES OF THE KENAI PENINSULA BOROUGH TO PROVIDE FOR A SHORT FORM OF CITATION TO THE CURRENT CODE OF ORDINANCES AND TO PROVIDE FOR A DIFFERENT SHORT FORM OF CITATION TO THE CODE OF ORDINANCES TO BE INSTITUTED UNDER THE CURRENT RECODIFICATION PROJECT.

WHEREAS, the Kenai Peninsula Borough is presently under contract to provide for recodification of the borough ordinances which will include bringing the ordinances up-to-date as well as rearranging and renumbering titles, chapters, and sections of the ordinances; and

WHEREAS, it is desirable that a short means of citation be provided to refer to the sections of the present code of ordinances and also that a distinguishing short form of citation be provided for referring to the various titles, chapters, and sections of the code of ordinances which will be adopted after recodification; Now Therefore,

BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1: Section 1.05.05 of the Code of Ordinances of the Kenai Peninsula Borough is hereby amended to read as follows:

Sec. 1.05.005. How Code Designated and Cited.

- (1) The ordinances embraced in the following chapters and sections, together with amendments or additions thereto, shall constitute and be designated the "Kenai Peninsula Borough Code of Ordinances" and may be so cited.
- (2) This code may also be cited in short form by using the letters "KPC" followed by the numbers of title, title and chapter, or title, chapter, and section--for example, this title may be cited as "KPC 1", this chapter as "KPC 1.05", and

(3) On completion of the recodification project now in progress, and on adoption of the code of ordinances prepared thereunder, said new code may be cited in short form by using the letters "KPB" followed by the numbers of title, title and chapter, or title, chapter, and section in the same manner as for the present code of ordinances.

Section 2: This ordinance takes effect on the day after enactment.
