## SUBSTITUTE ORDINANCE 74-74 72

AN ORDINANCE AUTHORIZING THE INCURRING OF INDEBTEDNESS FOR GENERAL OBLIGATION BONDS IN AN AMOUNT NOT TO EXCEED FOR THE PURPOSE OF CONSTRUCTING AND EQUIPPING THE FOLLOWING SCHOOLS:

WHEREAS, the continuing increase in population makes these additional school facilities necessary; and

WHEREAS, there is a time lag of up to three years before new construction is usable which could result in a vast decrease in educational quality due to crowded conditions; and

WHEREAS, large industrial construction projects are committed, which will result in a greatly increased tax base so that bond payments can be made without an increase in the tax rate; Now Therefore

BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. Indebtedness in the form of general obligation bonds in an amount not to exceed may be incurred by the Kenai Peninsula Borough for the purpose of raising funds for constructing and equipping the following schools:

Kenai Central High School Addition
East Homer Elementary School Addition
Soldotna Elementary School Addition
Bob Bartlett School (Tyonek)
Nikolaevsk Elementary School
Soldotna High School
Seward High School

Payment of the above described indebtedness shall be derived from taxes levied within the Kenai Peninsula Borough and from such other revenues as may be properly pledged for such payment, and the full faith and credit and resources of the Kenai Peninsula Borough shall be pledged to the repayment of the indebtedness so incurred.

Section 3. For purposes of the ballot the proposition on the ballot shall read as follows:
