AN ORDINANCE AMENDING KPC 25.10.020 TO EXEMPT THE SALE OF FOOD FROM THE KENAI PENINSULA BOROUGH SALES TAX.

WHEREAS, it appears that the financial condition of the Kenai Peninsula Borough is such that a reduction in taxes can be made without interfering with any essential services; and

WHEREAS, continuous inflation makes it more and more difficult for citizens of the borough to maintain their standard of living; and

WHEREAS, the tax reduction which would give relief to all citizens of the borough and particularly to the most needed would be an exemption of the sale of food; Now Therefore,

BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1: KPC 25.10.020 is hereby amended by adding a new subsection to be numbered (14) which shall read as follows:

"(14) Retail sales of food."

Section 2: This ordinance shall become effective January 1, 1976.
