## ORDINANCE 77-10

AN ORDINANCE MAKING A SUPPLEMENTAL APPROPRIATION FROM UNAPPROPRIATED FUNDS TO THE PLANNING DEPARTMENT OF \$30,000 FOR MATCHING EDA TITLE IX PLANNING FUNDS AND \$15,000 FOR MATCHING OCS - COASTAL MANAGEMENT GRANT FUNDS

WHEREAS, the Kenai Peninsula Borough is responsible for comprehensive planning within the Borough;

WHEREAS, the effects of onshore activities and associated population changes related to offshore oil and gas development will be felt Boroughwide;

WHEREAS, it is desirable to develop a strategy which will maximize the benefits of offshore oil and gas development while minimizing or eliminating potential problems associated with rapid and large scale changes in onshore activity and population;

WHEREAS, it is desirable that the Borough and cities within the Borough become eligible for all possible sources of funds for design and construction of facilities or provision of services which will be required to meet the demands of on and offshore activity and associated population changes;

WHEREAS, \$90,000 of Title IX funds are available to be used for developing a strategy for coping with the effects of Outer Continental Shelf oil and gas development if a local match of \$30,000 is appropriated;

WHEREAS, \$60,000 of OCS-Coastal Management Planning grant funds are available to the Kenai Peninsula Borough if local match of \$15,000 is appropriated; and

WHEREAS, there is an excess of \$45,000 in unappropriated funds; Now Therefore,

BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

- Section 1. The sum of \$30,000 is hereby appropriated to the Planning Department to match EDA Title IX funds to be used for developing a strategy for coping with the effects of Outer Continental Shelf oil and gas development.
- Section 2. The sum of \$15,000 is hereby appropriated to the Planning Department to match OCS-Coastal Management Planning grant funds to be used for the continuation of the Borough's OCS-Coastal Management planning program.
- Section 3. This ordinance takes effect on the day after enactment.
