ORDINANCE 77-57

AN ORDINANCE APPROPRIATING FUNDS FROM THE UNAPPROPRIATED SURPLUS TO FUND ACTIVITY BUSES, PUBLIC SWIMMING, DRIVER EDUCATION AND HOCKEY AS A PART OF SCHOOL DISTRICT'S EDUCATIONAL CURRICULUM.

WHEREAS, the assembly looks favorably upon the school district providing extra-curricular activity buses, extra-curricular and public swimming at the school pools, student driver education, and a student hockey program in connection with the educational curriculum; and

WHEREAS, the school board deleted these activities from the proposed school budget expenditures; and

WHEREAS, the assembly favors the reinstatement of these activities, and would support an appropriation to fund resolution of the school board reinstating any or all of these activities:

NOW THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. There is hereby appropriated from the unappropriated surplus in the borough's treasury the amount of \$269,527.00 to fund the following activities in the amounts stated:

- (1) Extra-curricular activity buses....\$ 40,000.00
- (2) Extra-curricular swimming and  
public swimming.....104,527.00
- (3) Student driver education program.. 110,000.00
- (4) Hockey program..... 15,000.00

Section 2. The appropriation and funding of money in

this ordinance is contingent upon the school board's adopting a resolution reinstating any or all of these named activities for the school year 1977-1978, provided that the appropriation grants will not be used for other than the specific activities set forth in the budgeted amounts.

Section 3. This ordinance takes effect upon its enactment; provided that the school board adopt a resolution within 90 days, otherwise this ordinance shall be null and void, and the monies appropriated shall revert to the central treasury of the borough.
