ORDINANCE 77-60

AN ORDINANCE AUTHORIZING THE EXPENDITURE OF BOROUGH FUNDS TO PROCEED WITH THE CONSTRUCTION DOCUMENTS PHASES OF ARCHITECTURAL SERVICES FOR PROPOSED PUBLIC SCHOOLS PROJECTS AT ANCHOR POINT, TUSTUMENA AND STERLING ELEMENTARY SCHOOLS, HOMER HIGH SCHOOL AND THE PROPOSED SOLDOTNA HIGH AND SOLDOTNA ELEMENTARY SCHOOLS.

WHEREAS, it appears that the most favorable conditions for competitive bidding for public construction contracts will occur on or about March 1, 1978; and

WHEREAS, it appears that architectural services for the construction documents phases can be completed in time for such competitive bidding season if authority to proceed is obtained; and

WHEREAS, time is of the essence and early completion of the construction documents may result in substantial savings in construction costs:

NOW THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. That \$635,000 be and hereby is appropriated from the unappropriated balance in the Borough treasury for the purpose of funding construction documents for schools.

Section 2. That the Mayor be and he hereby is authorized to expend these funds for the completion of construction documents phases of the architectural services

The amount of the expenditures authorized by this Ordinance shall be returned to the general treasury of the Borough from the proceeds of the sale of the school bonds after the school bond issue is funded, and these authorized expenditures shall properly be accounted for in the respective school projects.

Section 3. This ordinance becomes effective on the date of enactment.
