ORDINANCE 77-66

AN ORDINANCE MAKING APPROPRIATIONS FOR THE BALANCE OF FISCAL YEAR 1977-1978 TO NIKISKI FIRE SERVICE AREA AND THE NORTH PENINSULA RECREATION SERVICE AREA FOR SALARY AND BENEFIT ADJUSTMENTS.

WHEREAS, the Kenai Peninsula Borough contract with the employees requires salary and cost-of-living adjustments retroactive to 1 October, 1977; and

WHEREAS, the borough will increase the life insurance coverage of employees; and

WHEREAS, certain other adjustments have been made in car allowances and mileage and per diem;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. The sum of \$23,550 is hereby appropriated from unappropriated surplus to the Nikiski Fire Service Area fund for the following budget adjustments in fiscal year 1977-78.


