ORDINANCE 78-49

AN ORDINANCE TO AMEND SECTION 5.04.020 OF THE BOROUGH CODE OF ORDINANCES TO REQUIRE ALL UNENCUMBERED FUNDS REMAINING AT THE END OF A FISCAL YEAR TO BE USED TO REDUCE THE MILL RATE LEVY AND TO AMEND SECTION 5.04.060.

WHEREAS, the Borough general property tax base has continued to increase in dollar valuation as a result of the appreciated values of real estate and property in the Borough; and

WHEREAS, such increasing valuations and assessments have the effect of increasing the revenues of the Borough from the general property tax without the need to change the mill rate levied against the general property tax; and

WHEREAS, such increasing revenues result in unencumbered surpluses in the fiscal year's budgets; and

WHEREAS, the tax revenues should be calculated to derive sufficient revenues from tax sources in an amount calculated to produce sufficient revenue to finance a fiscal year's budget without producing a surplus of revenues over and above the amount of money needed to finance an approved budget,

NOW THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. That Section 5.04.020 of the Borough Code of ordinances is hereby amended to read as follows:

5.04.020 Budget proposal--Presented when--Contents--Borough mayor responsibility. During or prior to the eighth week preceding the first day of the fiscal year,


the borough mayor shall present to the assembly a budget proposal for the next fiscal year of the borough. Such budget proposal shall set forth the borough mayor's recommendations for and an analysis of the anticipated income and expenditures of the borough during the next fiscal year, together with comparative figures showing the estimated corresponding amounts for the current year and comparisons with the previous year. The proposed expenditures set forth in the budget proposal shall not exceed revenues of the borough. All unencumbered funds remaining at the end of the current fiscal year [MAY BE REALLOCATED FOR PURPOSES SET FORTH IN THE BUDGET PROPOSAL.] shall be used to reduce the mill rate which will be levied against the general property on the assessment rolls.

Section 2. That Section 5.04.060 of the Borough Code of ordinances is amended to read as follows:


5.04.060 Budget proposal--Adoption required when--  
Appropriation authority. After the public hearing, on the same day or another day following the hearing, and not less than 15 [10] days prior to the end of the fiscal year, the assembly in regular or special meeting shall, by resolution, adopt a budget for the following year and make an appropriation of the money needed therefor.

Section 3. This ordinance shall become effective immediately upon enactment.
