ORDINANCE 79-25

ADOPTING A COMPREHENSIVE PLAN FOR THE CITY OF SOLDOTNA AS A PART OF THE KENAI PENINSULA BOROUGH COMPREHENSIVE PLAN.

WHEREAS, the Borough Planning Commission is required to prepare and recommend to the assembly a comprehensive plan for all areas encompassed by the Borough; and

WHEREAS, the Borough Planning Commission is required by statute to review the Borough comprehensive plan every two years; and

WHEREAS, the Soldotna Advisory Planning Commission, after public hearing, has recommended a revised comprehensive plan for that area of the Borough within the boundaries of the City of Soldotna; and

WHEREAS, the Soldotna City Council has recommended that the City of Soldotna Comprehensive Development Plan be adopted by the Borough Assembly; and

WHEREAS, the Borough Planning Commission has reviewed the Soldotna Comprehensive Development Plan and has recommended that the assembly adopt the plan as amended;

NOW THEREFORE, BE IT ENACTED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. That the assembly adopts the "City of Soldotna Comprehensive Development Plan", Ted Forsi & Associates (1979) as the official Borough Comprehensive Plan within the boundaries of the City of Soldotna. The comprehensive plan, as approved and amended by the Resolution of the City of Soldotna Advisory Planning Commission adopted

Kenai Peninsula Borough Ordinance 79-25 Page 1 of 2 Pages March 7, 1979; by Resolution 79-9 of the City Council of Soldotna, on March 15, 1979, and by the Borough Planning Commission on April 16, 1979, is incorporated as a part of this resolution. The amendments to the comprehensive plan consist of 3 pages amending Item #1 (a) and (b), Items #2 (a), (b), (c), (d), (d-1), (d-2), Item #2 (e), (f) and (g), Item #3, Item #4, Item #5, Item #6, Item #7, and Item #8, and an amendment to paragraph E. Hospital Facilities consisting of 2 pages.

Section 2. That this ordinance takes effect immediately upon its enactment.
