## KENAI PENINSULA BOROUGH ORDINANCE 79-74

REZONING A PORTION OF BAYVIEW SUBDIVISION, CITY OF HOMER FROM RESIDENTIAL (R) DISTRICT TO COMMERCIAL (C) DISTRICT.

WHEREAS, the owners of Lots 4, 5, 9 and 10 of Johnson Addition of Tract A, Bayview Subdivision, City of Homer and Lots 117, 118, 134, 135, 136, 137, 138, 139, 140, 141, 142, 143, 144, 145, 146, 147, and 148 of Bayview Subdivision, City of Homer, have requested that these lots be rezoned from Residential (R) District to Commercial (C) District; and

WHEREAS, these lots are located on Bay Avenue south of Ocean Drive and west of Homer Spit Road, City of Homer; and

WHEREAS, the Homer Advisory Planning Commission, after public hearing, has recommended that the lots set forth above be rezoned from Residential (R) District to Commercial (C) District; and

That Lots 4, 5, 9, and 10 of Johnson Addition of Tract A, Bayview Subdivision, City of Homer, and Lots 117, 118, 134, 135, 136, 137, 138, 139, 140, 141, 142, 143, 144, 145, 146, 147, and 148 of Bayview Subdivision, City of Homer, be rezoned from Residential (R) District to Commercial (C) District.

Section 2. That the official zoning map for the City of Homer shall be amended to reflect the rezoning accomplished by this ordinance.

Section 3. That the Mayor is authorized to effectuate this ordinance, which takes effect immediately upon its enactment.
