ORDINANCE 80-42

AUTHORIZING RECEIPT OF COASTAL ZONE MANAGEMENT FUNDS FOR PREPARATION OF A HOMER SPIT COASTAL DEVELOPMENT PROGRAM AND INCREASING ESTIMATED COASTAL ZONE MANAGEMENT REVENUES AND APPROPRIATIONS.

WHEREAS, the State of Alaska has notified the Borough that the sum of \$130,000 has been allocated to the Borough from State of Alaska Coastal Zone Management Funds for preparation of a Homer Spit Coastal Development Program; and

WHEREAS, the City of Homer has notified the Borough that the City has appropriated the sum of \$14,500 as the City's share of the cost of preparing a Homer Spit Coastal Development Program; and

WHEREAS, the Borough Assembly has already allocated the sum of \$18,000 from Federal Revenue Sharing Funds to provide matching Borough funds for preparation of a Homer Spit Coastal Development Program; and

WHEREAS, preparation of a Homer Spit Coastal Development Program involves the study and resolution of current and anticipated interactions between the use of the Homer Spit for port, harbor and other transportation facilities and the critical habitat of commercially and recreationally valuable marine life; and

WHEREAS, development of the Homer Spit Coastal Development Plan, as a component of the overall Borough Coastal Development Plan, will assist in the development of the Homer Spit to the maximum extent consistent with the preservation of commercially and recreationally valuable marine life and will assist in obtaining necessary port and harbor facility permits from various state and federal agencies; and

WHEREAS, the Homer Spit study will involve the conduct of biological research which will be valuable in itself;

NOW THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. That the Assembly acknowledges and accepts authorization from the State of Alaska to expend the sum of \$162,500 of Coastal Zone Management Program Funds, which expenditures are subject to 80% reimbursement by the State, and that the Mayor is authorized to execute a contract with the State of Alaska Department of Community and Regional Affairs, which provides that the Department will reimburse the Borough in the amount of \$130,000 as the State's 80% share of the cost of preparing a Homer Spit Coastal Development Program. The form of agreement shall be substantially in accordance with the form attached to this Ordinance.

Section 2. That the Assembly acknowledges and accepts authorization by the City of Homer to expend the sum of \$14,500 of funds appropriated by the City of Homer, subject to 100% payment by the City, as the City's share of matching funds for the Homer Spit Coastal Zone Management Project.

Section 3. That the sum of \$162,500 is appropriated to Homer Spit Coastal Development Plan Contractual Services Account No. 12-41670-3400 from the sources and in the amounts set out below, and that estimated revenues in those accounts are increased in like amount:

Section 4. That the Mayor is authorized to effectuate this Ordinance which takes effect immediately upon its enactment.
