KENAI PENINSULA BOROUGH

ORDINANCE 80-43

AMENDING SECTION 2.08.020 OF THE BOROUGH CODE, TO PROVIDE THAT REGULAR MEETINGS OF THE ASSEMBLY SHALL ADJOURN AT MIDNIGHT.

WHEREAS, the Assembly has not established a regular time for the adjournment of Assembly meetings; and

WHEREAS, many Assembly meetings have continued well beyond midnight; and

WHEREAS, such lengthy Assembly meetings are discourteous to the public and to members of the Assembly; and

WHEREAS, it is difficult to give full and careful consideration to new business in the hours after midnight;


NOW THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. That Section 2.08.020 of the Borough Code is amended to read:

2.08.020 Time and place--Procedure for changes--
Notice responsibility. Regular meetings of the Assembly shall be held on the first and third Tuesday of each month at 7:30 p.m. in the Assembly Room of the Borough Administration Building unless for legitimate cause the Assembly by resolution or motion provides for holding any particular regular meeting on another day, at another time, or place. The resolution or motion shall set forth the reason for changing the regular meeting. Public notice of the changed meeting shall be made in at least one newspaper of general circulation in the Borough and the Assembly clerk shall post a notice of the changed regular meeting at such public places and in the usual manner for giving the public notice of Assembly meetings. Regular meetings of the Assembly shall be adjourned at 12:00 o'clock midnight, and any pending agenda items shall be taken up at the next meeting.

Section 2. That this ordinance takes effect immediately upon its enactment.
