KENAI PENINSULA BOROUGH

ORDINANCE 80-53

AUTHORIZING RECEIPT OF COASTAL ZONE MANAGEMENT FUNDS TO PROVIDE ASSISTANCE TO THE CITY OF KENAI AND INCREASING ESTIMATED COASTAL ZONE MANAGEMENT REVENUES AND APPROPRIATIONS.

WHEREAS, the preliminary draft of the Borough's coastal development program has identified the area at the mouth of the Kenai River as an area meriting special attention and assuring that marine-oriented industries are benefitted and that natural resources are not jeopardized; and

WHEREAS, the City of Kenai has formed a port and harbor commission to manage the development of the marine-oriented industry at the mouth of the Kenai River and its commission will assist in the development of a management plan for this area; and

WHEREAS, the State of Alaska has notified the Borough that the sum of \$51,200 has been allocated to the Borough from the State of Alaska Coastal Zone Management funds for the assistance to the City of Kenai for Ports and Harbors; and

WHEREAS, the City of Kenai has authorized local matching services and facilities in the amount of \$12,800 as its contribution; and

WHEREAS, the Borough exercises areawide planning authority within its boundaries and will subcontract with the City of Kenai to provide assistance to the City of Kenai Ports and Harbors;

NOW THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1: That the Mayor is authorized to execute a contract with the State of Alaska, Department of Community and Regional Affairs, to provide that the State will reimburse the Borough in the sum of \$51,200 as the State's 80% share of this program, and the Assembly acknowledges and accepts authorization from the State of Alaska to expend Coastal Zone Management Program funds to assist the City of Kenai for Ports and Harbors. The agreement shall be in the form of agreement incorporated into this resolution as ATTACHMENT A.

Section 2. The Assembly acknowledges and accepts the offer of the City of Kenai to provide services and facilities in support of the City of Kenai for Ports and Harbors. In lieu of a share of matching funds, the City's share of matching services and facilities for this project is in the amount of \$12,800.

Section 3. The sum of \$51,200 is appropriated to the City of Kenai Coastal Development Plan Contractual Services Account No. 12-41680-3400, and estimated revenues are increased in the amount of \$51,200.00 in Coastal Development Program Revenue Account No. 12-34180.

Section 4. That the Mayor is authorized to execute a contract with the City of Kenai to provide for the administrative support and assistance to the City of Kenai for Ports and Harbors, provide for assistance in the preparation of a management plan for the industrial development at the mouth of the Kenai River.

Section 5. That this ordinance takes effect immediately upon its enactment.
