KENAI PENINSULA BOROUGH

ORDINANCE 81-6

PROVIDING THAT THE ENACTMENT OF EVERY NEW SECTION IN THE BOROUGH CODE OF ORDINANCES SHALL BE ACCOMPANIED BY THE REPEAL OR REVISION OF TWO OTHER SECTIONS OF THE CURRENT CODE.

WHEREAS, a significant number of new Ordinances have been proposed for enactment by the Borough Assembly; and

WHEREAS, the Assembly finds that the improvement of the current Borough Code to repeal or revision of existing sections should not be overlooked when proposing new legislation; and

WHEREAS, the Assembly finds that it is desirable to institute a process for the ongoing repeal or revision of less important sections of the Borough Code, and to minimize the legislation of regulations governing the people,

NOW THEREFORE BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1: That Chapter 2.08 of the Borough Code is amended by adding a new section to be number 2.08.095, which reads;

2.08.095 Agenda--Introduction of Codified Ordinances-Repeal or Revision of Other Code Sections Required. Every Ordinance which would add a new section to a chapter of the Borough Codified Ordinances, or which would add a new chapter or title to the Borough Codified Ordinances, shall also provide for the repeal or revision of two sections of the existing Borough Code. The sponsor of the Ordinance shall designate the sections to be repealed or revised.
