ORDINANCE 81-104

INCREASING ESTIMATED REVENUE, PROCEEDS FROM BONDS SALES IN THE AMOUNT OF \$12,169,000, AND INCREASING APPROPRIATIONS BY \$12,169,000 FOR THE CONSTRUCTION, FURNISHING, AND EQUIPPING THE PUBLIC SCHOOL PROJECTS AT ANCHOR POINT, COOPER LANDING, KENAI CENTRAL HIGH, MCNEIL CANYON AND NORTH KENAI.

WHEREAS, at the regular election of October 6, 1981, the electorate of the Kenai Peninsula Borough approved Ordinance 81-78, by which the Kenai Peninsula Borough was authorized to incur General Obligation Bonded Indebtedness in an amount not to exceed \$12,169,000 for the purpose of constructing, furnishing, and equipping the following public school projects:

McNeil Canyon	6,249,000
North Kenai	3,283,000

WHEREAS, Resolution 81-179 was adopted on October 13, 1981, confirming the results of the regular election held on October 6, 1981, authorizing the issuance of General Obligation Bonds of the Kenai Peninsula Borough in an amount not to exceed \$12,169,000.

NOW THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. The sum of \$1,643,000 is hereby appropriated to the Capital Projects Fund from the proceeds of the sale of General Obligation Bonds of the Kenai Peninsula Borough for Anchor Point.

Section 2. The sum of \$994,000 is hereby appropriated to the Capital Projects Fund from the proceeds of the sale of General Obligation Bonds of the Kenai Peninsula Borough for Cooper Landing.

Section 3. The sum of \$6,249,000 is hereby appropriated to the Capital Projects Fund from the proceeds of the sale of General Obligation Bonds of the Kenai Peninsula Borough for McNeil Canyon.

Section 4. The sum of \$3,283,000 is hereby appropriated to the Capital Projects Fund from the proceeds of the sale of General Obligation Bonds of the Kenai Peninsula Borough for North Kenai.

Section 5. That the Mayor is authorized to expend an amount not to exceed \$614,000 to complete the construction document phases of the architectural services under contracts for the public school projects, limited to the following expenditures for each school:

Anchor Point	\$ 84,000
Cooper Landing	77,000
McNeil Canyon	250,000
North Kenai	203,000
	<u>\$614,000</u>

Section 7. This ordinance shall take effect on the day of its enactment.
