KENAI PENINSULA BOROUGH

ORDINANCE 81-114

REZONING CERTAIN LOTS WITHIN FIDALGO SUBDIVISION, CITY OF KENAI FROM CONSERVATION DISTRICT TO GENERAL COMMERCIAL DISTRICT.

WHEREAS, the City of Kenai has requested that certain lots in the subdivision be rezoned from the Conservation District to the General Commercial District; and

WHEREAS, these lands are located within the commercial area of the City of Kenai, at the intersection of First Street and Bidarka Street; and

WHEREAS, the City of Kenai has requested that these lands be rezoning from Conservation District to General Commercial District and the Kenai Advisory Planning Commission, after public hearing, unanimously recommended that the Assembly rezone these lands as requested; and

WHEREAS, the Borough Planning Commission, after public hearing, recommend unanimously that these lands be rezoned from the Conservation District to the General Commercial District;

NOW THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1: That those lands lying within the boundaries of the City of Kenai described as Lots 1 & 2, Block 3, Fidalgo Subdivision, Kenai Recording District, are rezoned from Conservation District to General District.

Section 2: That the official zoning map for that portion of the Borough lying within the boundaries of the City of Kenai shall be amended to reflect the rezoning accomplished by this Ordinance.

Section 3: That this Ordinance takes effect immediately upon its enactment.
