ORDINANCE 81-116

REZONING CERTAIN LOTS WITHIN F.B.O. SUBDIVISION, CITY OF KENAI FROM CONSERVATION DISTRICT TO LIGHT INDUSTRIAL DISTRICT.

WHEREAS, the City of Kenai has requested that certain lots in the subdivision be rezoned from the Conservation District to the Light Industrial District; and

WHEREAS, these lands are located within the commercial area of the City of Kenai, near the Kenai Airport; and

WHEREAS, the City of Kenai has requested that these lands be rezoning from Conservation District to Light Industrial District and the Kenai Advisory Planning Commission, after public hearing, unanimously recommended that the Assembly rezone these lands as requested; and

WHEREAS, the Borough Planning Commission, after public hearing, recommend unanimously that these lands be rezoned from the Conservation District to the Light Industrial District;

NOW THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1: That those lands lying within the boundaries of the City of Kenai described as F.B.O. Subdivision, Kenai Recording District, are rezoned from Conservation District to Light Industrial District.

Section 2: That the official zoning map for that portion of the Borough lying within the boundaries of the City of Kenai shall be amended to reflect the rezoning accomplished by this Ordinance.

Section 3: That this Ordinance takes effect immediately upon its enactment.
