ORDINANCE 81-12

MAKING TECHNICAL CORRECTIONS TO SECTION 2.04.060 OF THE BOROUGH CODE REGARDING THE SALARY OF THE BOROUGH MAYOR.

WHEREAS, Section 2.04.060A of the Borough Code states that the compensation of the Borough Mayor shall be \$33,000 per year, as adjusted by the cost of living indexes from time to time; and

WHEREAS, the adjusted salary of the Borough Mayor as of January 1, 1981 was \$54,804 annually; and

WHEREAS, the salary is subject to further readjustment in accordance with the National Consumer Price Index at the end of every term of office; and

WHEREAS, Section 29.23.530 of the Alaska Statutes was recently amended to provide that the salary of the Borough Mayor could be increased by the Assembly from time to time during the incumbent mayor's term of office; and

WHEREAS, it is desirable that the Assembly amend Section 2.04.060 of the Borough Code by updating the salary figures set forth in that section and to eliminate the uncertainty of referring to the National Consumer Price Index which requires calculation of an amount not set forth in the Legislature; and

WHEREAS, the Assembly can address any further increases in the salary of the mayor and be specific as to the amount;

NOW THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

- Section 1. That current Section 2.04.060 of the Borough Code is repealed.
- Section 2. That Chapter 2.04 of the Borough Code is amended by adding a section, to be number 2.04.060 which reads:
 - "2.04.060 Salary. A. Compensation for the Borough Mayor is established at \$54,804 per year.

Kenai Peninsula Borough Ordinance 81-12 Page 1 of 2 Pages. B. The Assembly may provide for an increase in the mayor's compensation to take effect at the beginning of a term of office, but the Assembly may not reduce the compensation of the Borough Mayor during his term of office.
