ORDINANCE 81-121

ACCEPTING A GRANT AND APPROPRIATING FUNDS FOR FIRE SERVICE TRAINING IN THE NIKISKI FIRE SERVICE AREA.

WHEREAS, the Nikiski Fire Service Area has applied for a grant from the State of Alaska, Department of Education for a Fire Service Training Program; and

WHEREAS, the State of Alaska has notified the fire service area that a grant has been approved; and

WHEREAS, it is necessary for the Assembly to accept the grant and to appropriate funds for the Fire Service Training Program;

NOW THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. That a grant of funds from the State of Alaska, Department of Education in the amount of \$10,782 is accepted, to be used to pay professional services costs consisting of instructor fees, travel and per diem, textbooks and supplies, and other related expenses for an Instructor Development Course to be conducted by the International Society of Fire Service Instructors under the sponsorship of the Nikiski Fire Service Area.

Section 2. That the amount of \$10,782 is appropriated to the Fire Service Training Account No. 20-43110.7501 and the estimated revenue in the Adult Education Grant Account No. 20-34420.0000 is increased by the amount of this grant.

Section 3. That this ordinance takes effect immediately upon its enactment.
