KENAI PENINSULA BOROUGH

ORDINANCE 81-122

TO AMEND SECTION 20.04.040(A) OF THE BOROUGH CODE OF ORDINANCES TO EXCLUDE THE CITY OF KENAI FROM THE PROVISIONS WHICH ELIMINATE THE PREPARATION OF PLATS FOR DESIGNATED SUBDIVISIONS.

WHEREAS, KPB 20.04.040(A) provides that no plat need be submitted to the Planning Commission for lands divided into designated parcels; and

WHEREAS, KPB 20.04.040(A) is not applicable within the boundaries of a first class city exempted from its provision by Assembly ordinance; and

WHEREAS, the Council of the City of Kenai, by Resolution 81-111, has requested the Borough Assembly to enact an ordinance exempting the City of Kenai from these provisions;

NOW THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. That KPB 20.04.040(A) shall not apply to the subdivision of land within the boundaries of the City of Kenai, and KPB 20.04.040(A) is amended by enacting Subparagraph 2 to read:

2. The City of Kenai is exempt from the provisions of KPB 20.04.040(A).

Section 2. That this ordinance takes effect immediately upon its enactment.
