ORDINANCE 81-125

ACCEPTING A GRANT AND APPROPRIATING FUNDS FOR EQUIPMENT FOR THE BEAR CREEK FIRE SERVICE AREA.

WHEREAS, the Bear Creek Fire Service Area made application for federal funds under the Rural Community Fire Protection Program; and

WHEREAS, the State of Alaska has notified the service area that a grant has been approved for the purchase of various equipment for the fire department; and

WHEREAS, it is necessary for the Assembly to accept the grant and to appropriate funds for the purchase of various equipment for the Bear Creek Fire Service Area;

NOW THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. That a grant of \$2,848 under the Rural Community Fire Protection Program is accepted by the Borough for the Bear Creek Fire Service Area to be used for the purchase of radios, foam and dry chemicals, and other fire training equipment.

Section 2. That the amount of \$2,848 is appropriated from the Grant Equipment Account No. 24-43610.8310, and the estimated revenue account, Rural Community Fire Protection Program No. 43-34410 is increased by the amount of this grant.

Section 3. That this ordinance takes effect immediately upon its enactment.
