ORDINANCE 81-21

AMENDING SECTION 2.12.070 OF THE BOROUGH CODE OF ORDINANCES TO INCREASE THE ALLOWANCE FOR REIMBURSABLE EXPENSES PAID TO ASSEMBLY MEMBERS TO \$250 PER MONTH, AND TO \$300 PER MONTH TO THE ASSEMBLY PRESIDENT.

WHEREAS, at all levels of government, national, state, and local, there is a public outcry against excessive governmental expenditures; and

WHEREAS, the inflationary spiral in the United States is deemed by the general public to be the number one problem in American society; and

WHEREAS, excessive government spending contributes to the inflationary spiral; and

WHEREAS, the legislative bodies at all levels of government which control purse strings can set an example by reducing expenses as an expression of recognizing the legitimate concern of the public regarding the level of governmental expenditures;

NOW THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. That Section 2.12.070 of the Borough Code of ordinances is amended to read:

2.12.070 Compensation--Additional expenses.

A. Assemblymen shall receive an allowance for expenses which would otherwise not be reimbursed in the amount of (\$200.00) \$250.00 per month, except the assembly president, who shall receive a similar expense allowance in the amount of (\$250.00) \$300.00 per month.
