ORDINANCE 81-30

APPROVING THE TOTAL AMOUNT OF THE SCHOOL BUDGET AND APPROPRIATING \$5,419,965 FOR SCHOOL PURPOSES, AND \$25,000 FOR THE ANNUAL SCHOOL DISTRICT AUDIT FOR FISCAL YEAR 1981-82.

WHEREAS, Section 14.14.060 (c) of the Alaska Statutes requires that the school budget be submitted to the Assembly by April 1 for approval of the total amount; and

WHEREAS, the Assembly must determine the total amount of money to be made available from local sources for school purposes within thirty days of the receipt of the school budget; and

WHEREAS, the Assembly is required by law to appropriate this money for school purposes on or before May 31; and

WHEREAS, the Assembly directs an annual audit of the school district by independent auditors;

NOW THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. The Borough Assembly approves the total school operations budget of \$33,453,741 for the fiscal year July 1, 1981, through June 30, 1982.

Section 2. The sum of \$5,419,965 is appropriated to the school fund from local sources for school purposes for the fiscal year July 1, 1981, through June 30, 1982; provided however, that the school fund from local sources shall be reduced by the amount that the funds which are available to the school district from all other sources for the general operating fund and the grant and special revenue funds, Fiscal Year 1981-82, exceed \$28,033,776; and \$25,000 is appropriated for the expense of the annual school district audit.

Section 3. That this ordinance takes effect immediately upon its enactment.
