


ORDINANCE CERTIFICATION

ORDINANCE 81-32

APPROPRIATING ADDITIONAL FUNDS FOR THE NINILCHIK SCHOOL  
ADDITIONS AND ALTERATIONS PROJECT.

WHEREAS, the Assembly, by Resolution 81-26, approved design development documents for the proposed Ninilchik School Additions and Alterations Project and authorized the Borough to proceed with the preparation of construction documents; and

WHEREAS, the Assembly approved a tentative construction budget for the basic project and for the additive alternates; and

WHEREAS, bond issue funds are insufficient and additional moneys must be appropriated to complete the basic project and the additive alternates; and

WHEREAS, the Borough School District Board of Education, at its meeting of February 2, 1981, requested that the sum of \$542,500 be transferred from the current 1980-1981 Fiscal Year Borough Local Effort Appropriation and be utilized to assist in the construction of the Ninilchik Project; and

WHEREAS, the appropriation of additional funds is necessary in order to meet the approved construction budget;

NOW THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE  
KENAI PENINSULA BOROUGH:

Section 1. That appropriations in the General Fund Account - Transfer to the School Fund, FY80-81, #01-41990-7602 - are reduced in the amount of \$542,500; and appropriations in the General Fund Account - Transfer to Capital Projects Fund Account - #01-41990-7605 - are increased in the amount of \$542,500, and transferred to the Ninilchik School Construction Contingency Account #61-13981-9007.

Section 2. That the amount of \$604,015 is appropriated from the Borough's unappropriated surplus to the General Fund Account - Transfer to Capital Projects - #01-41990-7605, and transferred to Ninilchik School Construction Contingency Account #61-13981-9007.

Section 3. That this ordinance takes effect immediately upon its enactment.
