- Section 3. The sum of \$253,281 is hereby appropriated in the Land Trust Fund for the fiscal year July 1, 1981, through June 30, 1982.

- Section 5. The sum of \$770,500 is hereby appropriated in the Federal Revenue Sharing Fund for the fiscal year July 1, 1981, through June 30, 1982.
- Section 6. The sum of \$1,128,556 is hereby appropriated in the Capital Projects Fund for the fiscal year July 1, 1981, through June 30, 1982.
- Section 7. The sum of \$1,710,000 appropriated in the General Fund entitled Tax Credits shall be utilized as a tax credit of 30% of the tax amount on each property tax account of the Kenai Peninsula Borough for tax year 1981.
