MAKING APPROPRIATIONS FOR FISCAL YEAR 1981-82 TO ALL SERVICE AREAS WITHIN THE KENAI PENINSULA BOROUGH.

BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. The sum of \$1,187,243 is hereby appropriated to the Central Peninsula Hospital Service Area fund for operations for the fiscal year July 1, 1981, through June 30, 1982.

Section 2. The sum of \$1,560,788 is hereby appropriated to the Nikiski Fire Service Area fund for operations for the fiscal year July 1, 1981, through June 30, 1982.

Section 3. The sum of \$661,527 is hereby appropriated to the South Peninsula Hospital Service Area fund for operations for the fiscal year July 1, 1981, through June 30, 1982.

Section 4. The sum of \$477,194 is hereby appropriated to the North Peninsula Recreation Service Area fund for operations for the fiscal year July 1, 1981, through June 30, 1982.

Section 5. The sum of \$68,673 is hereby appropriated to the Bear Creek Fire Service Area fund for operations for the fiscal year July 1, 1981, through June 30, 1982.

Section 6. The sum of \$10,218 is hereby appropriated to the Kenai River Bridge Subdivision Service Area fund for operations for the fiscal year July 1, 1981, through June 30, 1982.

Section 7. The sum of \$125,390 is hereby appropriated to the Ridgeway Fire Service Area fund for operations for the fiscal year July 1, 1981, through June 30, 1982.
