ORDINANCE 81-39

MAKING APPROPRIATIONS FOR ACCRUED ANNUAL LEAVE LIABILITY  
AT JUNE 30, 1981.

WHEREAS, accrued annual leave is an unfunded liability of the Kenai Peninsula Borough and Service Areas; and

WHEREAS, this liability has become a material amount on a fund basis; and

WHEREAS, the Assembly has determined that this liability should be funded;

NOW THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. That \$295,148 of Federal Revenue Sharing monies be transferred to the General Fund (account number 38180) to fully fund the accrued annual leave at June 30, 1981.

Section 2. That appropriations for accrued annual leave (account number 1400) be made to the following departments in the General Fund:

Section 3. That \$13,698 of Federal Revenue Sharing monies be transferred to the O.F.D.P. Fund (account number 38180), and appropriations for accrued annual leave (account number 1400) be increased by \$13,698.

Section 4. That estimated revenue for the beginning balance (account number 3000) and appropriations for accrued annual leave (account number 1400) be increased by \$2,747 in the Land Management Fund.

Section 5. That estimated revenue for the beginning balance (account number 3000) and appropriations for accrued annual leave (account number 1400) be increased by \$67,426 in the Nikiski Fire Service Area Fund.

Section 6. That estimated revenue for the beginning balance (account number 3000) and appropriations for accrued annual leave (account number 1400) be increased by \$4,048 in the North Peninsula Recreation Service Area Fund.

Section 7. That this ordinance takes effect immediately upon its enactment.
