ORDINANCE 81-40

APPROPRIATING SURPLUS FUNDS TO THE BEAR CREEK FIRE SERVICE AREA.

WHEREAS, the Assembly approved a 1980-1981 budget of \$20,720 for the Bear Creek Fire Service Area; and

WHEREAS, this budget included certain sums for maintenance which the Fire Service Area Board has determined to be inadequate; and

WHEREAS, the Board at its meeting of February 11, 1981, requested that the Assembly appropriate funds which were not expended from the Fiscal Year 1979 Budget, to be appropriated among various maintenance accounts;

NOW THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. That the Sum of \$12,317 is appropriated from Bear Creek Fire Service Area 1979 unappropriated surplus account number 24-3000 to the following accounts:

24-43610-2620	Vehicle Maintenance	\$5,000
24-43610-2100	Communications	\$1,000
24-43610-2100	Radio Maintenance	\$4,000
24-43610-2640	Building Maintenance	\$1,000
24-43610-3000	Travel & Subsistence	\$1,317

Section 2. That this ordinance takes effect immediately upon its enactment.
