KENAI PENINSULA BOROUGH
ORDINANCE 82-35 (Substitute)

MAKING APPROPRIATIONS TO THE SERVICE AREAS IN THE BOROUGH
FOR FISCAL YEAR 1982-83.

WHEREAS, Alaska statutes and the Borough Code of Ordinances require the Mayor to present a budget proposal for the fiscal year 1982-83; and

WHEREAS, as a part of the Borough budget, the Mayor has prepared proposed budgets for the service areas with the advice and consultation of the various service area boards; and

WHEREAS, the Assembly has considered these budget proposals;

NOW THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. That \$2,024,000 is appropriated to the Central Kenai Peninsula Hospital Service Area fund for operations for the fiscal year July 1, 1982, through June 30, 1983.

Section 2. That \$1,921,000 is appropriated to the Nikiski Fire Service Area fund for operations for the fiscal year July 1, 1982, through June 30, 1983.

Section 3. That \$661,527 is appropriated to the South Peninsula Hospital Service Area fund for operations for the fiscal year July 1, 1982, through June 30, 1983.

Section 4. That \$533,101 is appropriated to the North Peninsula Recreation Service Area fund for operations for the fiscal year July 1, 1982, through June 30, 1983.

Section 5. That \$63,600 is appropriated to the Bear Creek Fire Service Area fund for operations for the fiscal year July 1, 1982, through June 30, 1983.

Section 6. That \$130,465 is appropriated to the Ridgeway Fire Service Area fund for operations for the fiscal year July 1, 1982, through June 30, 1983.

Section 7. That \$29,600 is appropriated to the East Kenai Peninsula Road Service Area fund for operations for the fiscal year July 1, 1982, through June 30, 1983.

Section 8. That \$446,800 is appropriated to the Central Kenai Peninsula Road Service Area fund for operations for the fiscal year July 1, 1982, through June 30, 1983.

Section 9. That \$216,860 is appropriated to the South Kenai Peninsula Road Service Area fund for operations for the fiscal year July 1, 1982, through June 30, 1983.

Section 10. That \$138,940 is appropriated to the North Kenai Peninsula Road Service Area fund for operations for the fiscal year July 1, 1982, through June 30, 1983.

Section 11. That \$451,152 is appropriated to the Central Peninsula Emergency Medical Service and Ambulance Service Area fund for operations for the fiscal year July 1, 1982, through June 30, 1983.

Section 12. This ordinance takes effect at 12:01 a.m. on July 1, 1982.
