ORDINANCE 83-22

AMENDING CHAPTER 2.08 OF THE KENAI PENINSULA BOROUGH CODE OF ORDINANCES TO PROVIDE FOR A CONSENT AGENDA AND PUBLIC OR ASSEMBLY COMMENTS OR QUESTIONS CONCERNING ITEMS PLACED ON THE CONSENT AGENDA

WHEREAS, the Assembly finds that meetings could be expedited by changing its procedure to include a consent agenda for those items not requiring a separate vote or which are routine; and

WHEREAS, this procedure could allow more time for discussion for those matters of import or shorten the meetings; and

WHEREAS, adequate provision must be made for removal of an item on the consent agenda and/or Assembly or public questions or comments on an item on the consent agenda;

NOW THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. That KPB 2.08.120 is amended as follows:

2.08.120 Order of business. The order of business shall be:

- A. Call to order;
- B. Pledge of allegiance;
- C. Invocation;
- D. Roll call;
- (E. SEATING OF NEW ASSEMBLY MEMBERS;)
- E. Vacancy, designation, or seating of assembly members;
- F. Approval of minutes of previous meetings;
- G. Committee reports;
- H. Agenda approval;
- I. Ordinance hearings or other public hearings;
- (J. INTRODUCTION OF ORDINANCES;)
- J. Consent agenda; (questions or comments on items contained therein, removal of items, approval, action)
- K. Consideration of resolutions;
- L. Consideration of items removed from consent agenda;

- M. (L) Pending legislation;
- N. (M) Formal presentations with prior notice upon matters not on the meeting agenda;
- O. (N) Mayor's report;
- P. (O) Other business;
- Q. (P) Assembly and Mayor's comments;
- R. (Q) Public comments and public presentations upon matters not contained in the Assembly's agenda for the meeting;
- S. (R) Informational materials and reports;
- T. (S) Notice of next meeting and adjournment.

Section 3. That KPB 2.08.130 is amended by adding a new subsection to read:

C. Public presentations on any item included in the consent agenda will be allowed prior to consideration of consent agenda.

Section 4. That KPB 2.08 is amended by adding a new section to read as follows:

2.08.170 Consent agenda A. The consent agenda shall be as follows:

1. Introduction of ordinances;
2. Administration generated resolutions at the Mayor's discretion;
3. Unnumbered recognition resolutions;
4. Approval of school furnishings and equipment;
5. Appointments of individuals to boards and commissions
6. Receipt of the financial report;
7. Acknowledging receipt of change order documentation.

B. Assembly members may comment on or question any item contained in the consent agenda. Upon request of any assembly member an individual item may be removed to be considered separately.

Section 5. This ordinance shall take effect on the day of its enactment.
