- Section 2. That \$2,154,742 is appropriated to the Nikiski Fire Service Area fund for operations for the fiscal year July 1, 1983, through June 30, 1984.
- Section 3. That \$1,321,751 is appropriated to the South Peninsula Hospital Service Area fund for operations for the fiscal year July 1, 1983, through June 30, 1984.
- Section 4. That \$567,304 is appropriated to the North Peninsula Recreation Service Area fund for operations for the fiscal year July 1, 1983, through June 30, 1984.
- Section 5. That \$57,600 is appropriated to the Bear Creek Fire Service Area fund for operations for the fiscal year July 1, 1983, through June 30, 1984.
- Section 6. That \$241,747 is appropriated to the Ridgeway Fire Service Area fund for operations for the fiscal year July 1, 1983, through June 30, 1984.
