## KENAI PENINSULA BOROUGH

## ORDINANCE 83-46

AMENDING SECTION 2.08.09 OF THE KENAI PENINSULA BOROUGH CODE OF ORDINANCES TO INCLUDE ASSEMBLY COMMITTEES WITHIN THE PROVISIONS GOVERNING AGENDA PREPARATION AND CLARIFYING PROCEDURE.

WHEREAS, As 29.48.150 provides that legislation may be introduced by an Assembly member, a committee of the Assembly or the Mayor; and

WHEREAS, KPB 2.08.09 provides the procedure for developing the Assembly agenda but appears to affect only the Assembly; and

WHEREAS, KPB provides for the exclusion of legislation not placed on the agenda unless permitted by the 2/3 vote provided in KPB 2.08.100 but is written in such a manner so as to be difficult to read;

NOW THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. That Section 2.08.090 of the Kenai Peninsula Borough Code of Ordinances be repealed, reenacted and amended as Sections 2.08.084; 2.08.088; 2.08.092; and 2.08.096 as follows:

2.08.084 Agenda--Introduction of ordinances and resolutions. Ordinances, resolutions and other items of business to be introduced and considered by the borough assembly at a regular meeting of the assembly shall be placed on a meeting agenda prepared by the borough clerk. At the time that proposed legislation is ready for introduction and consideration of the assembly, an assembly member or committee of the assembly proposing to place a legislative matter on the agenda of a regular assembly meeting shall inform the borough clerk by 4:30 p.m. of the second Wednesday preceding the meeting at which the matter is to be introduced or considered. Any items not placed on the agenda by that time shall be deferred until the next assembly meeting, unless the assembly votes to consider the item pursuant to Section 2.08.100.

2.08.088 Agenda--Defeated ordinances--Reintroduction. An ordinance which has been introduced to the assembly and disapproved after consideration and public hearing or which has been vetoed by the mayor may not be reintroduced in the assembly for a period of 60 days

tollowing disapproval or veto.

2.08.092 Agenda--Defeated resolutions--Reintroduction. A resolution which has been disapproved by the assembly or vetoed by the mayor may Not be reintroduced in the assembly for a period of 60 days following disapproval or veto. The 60 day limitation does not apply to a motion to introduce an ordinance.

2.08.096 Agenda--Legislative items continued. Any legislative items pending on the assembly's agenda without a specific hearing date may be considered either at an assembly meeting following the assembly meeting at which notice of consideration of the legislative items is given by an assembly member, or at the next assembly meeting after notice to the Clerk as provided in Section 2.08.084 for the inclusion in the packet.

Section 2. That this ordinance shall take effect on the day of its enactment.
