KENAI PENINSULA BOROUGH  
 ORDINANCE 85-12 SUBSTITUTE

AUTHORIZING THE EXPENDITURE OF \$201,676 OF BOROUGH FUNDS TO PROCEED THROUGH THE DESIGN DEVELOPMENT PHASE OF ARCHITECTURE FOR PROJECT MANAGEMENT SERVICES FOR THE PROPOSED 1985 SCHOOL BOND PROJECTS, FOR THE NEW 13,500 SQUARE FOOT HOPE SCHOOL, THE NEW 40,000 SQUARE FOOT NIKISKI ELEMENTARY SCHOOL, FOR THE NEW 50,000 SQUARE FOOT KENAI ELEMENTARY SCHOOL.

WHEREAS, the Kenai Peninsula Borough Assembly authorized architectural and project management services for the schematic design and comprehensive cost projection phases for these projects on December 11, 1984 by:

WHEREAS, architectural design development is required to finalize the comprehensive cost for each of the subject projects prior to placing on the October 1985 School Bond Ballot.

NOW THEREFORE BE IT ORDAINED BY THE KENAI PENINSULA BOROUGH ASSEMBLY THAT:

Section 1. The sum of \$201,676 is hereby appropriated from the unappropriated balance of the Borough central treasure for the purpose of completion of design development phase for the above school projects.


Section 2. The Mayor is hereby authorized to utilize these funds for the completion of the design development phases for each of the following proposed public school projects and that these funds are assigned to the following accounts:

New Hope School	401-710401-49999	\$ 56,078
New Kenai School	401-730500-49999	\$ 79,404
New Nikiski School	401-710801-49999	\$ 66,194
	TOTAL:	\$201,676

All sums shall be expended in accordance with contracts previously approved for each project. The expenditures authorized by this ordinance shall be returned to the central treasure of the Borough from the proceeds of the sale of the school bonds, after the school bond issue is funded and those authorized expenditures shall be properly accounted for in the respective school project.

Section 3. This Ordinance 85-12 Amended takes effect immediately upon its enactment.
