KENAI PENINSULA BOROUGH

ORDINANCE 85-46

AUTHORIZING THE RECEIPT OF VARIOUS GRANTS FROM THE STATE OF ALASKA TOTTALLING \$2,856,500 MADE BY CHAPTER 96, SESSION LAWS OF ALASKA 1985, AND APPROPRIATING THE FUNDS TO PROJECT ACCOUNTS.

WHEREAS, the State of Alaska has notified the Kenai Peninsula Borough that the sum of \$2,856,500 has been appropriated for grants to the Borough by Chapter 96, SLA 1985 for the development of specific capital projects; and

WHEREAS, Chapter 96, SLA 1985 provides that \$650,000 shall be allocated to the North Fork Road; and

WHEREAS, Chapter 96, SLA 1985 provides that \$600,000 shall be allocated to Robinson Loop Road; and

WHEREAS, Chapter 96, SLA 1985 provides that \$615,000 shall be allocated to Lamplight Road; and

WHEREAS, Chapter 96, SLA 1985 provides that \$41,500 shall be allocated for the design of secondary roads; and

WHEREAS, KPB Resolution 81-100 requires that design funds be expended on the qualifying road with the highest daily traffic count; and

WHEREAS, the secondary road with the highest traffic count is West Poppy Lane with an average daily traffic count of 800; and

WHEREAS, Chapter 96, SLA 1985 provides for \$950,000 for State maintained Borough roads; and

WHEREAS, Chapter 96, SLA 1985 requires the legislative body enact an ordinance authorizing the municipality to receive and spend the money provided by the entitlement;

NOW THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. That the Mayor is authorized to accept grants for road projects in the amount of \$2,856,500 made by Chapter 96, SLA 1985.

Section 2. That the estimated revenue for the Road Capital Projects Fund is increased by the sum of \$2,856,500 and that
