KENAI PENINSULA BOROUGH

ORDINANCE 86-38

MAKING APPROPRIATIONS TO THE SERVICE AREAS IN THE BOROUGH FOR FISCAL YEAR 1986-87.

WHEREAS, Alaska statutes and the Borough Code of Ordinances require the Mayor to present a budget proposal for the fiscal year 1986-87; and

WHEREAS, as a part of the Borough budget, the Mayor has prepared proposed budgets for the service areas with the advice and consultation of the various service area boards; and

WHEREAS, the assembly has considered these budget proposals;

NOW THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. That \$2,905,300 is appropriated to the Central Kenai Peninsula Hospital Service Area fund for operations for the fiscal year July 1, 1986, through June 30, 1987.

Section 2. That \$2,216,534 is appropriated to the Nikiski Fire Service Area fund for operations for the fiscal year July 1, 1986, through June 30, 1987.

Section 3. That \$2,011,954 is appropriated to the South Peninsula Hospital Service Area fund for operations for the fiscal year July 1, 1986, through June 30, 1987.

Section 4. That \$680,062 is appropriated to the North Peninsula Recreation Service Area fund for operations for the fiscal year July 1, 1986, through June 30, 1987.

Section 5. That \$99,015 is appropriated to the Bear Creek Fire Service Area fund for operations for the fiscal year July 1, 1986, through June 30, 1987.

Section 6. That \$879,352 is appropriated to the Ridgeway/Sterling Fire Service Area fund for operations for the fiscal year July 1, 1986, through June 30, 1987.

Section 7. That \$62,386 is appropriated to the East Kenai Peninsula Road Maintenance Service Area fund for operations for the fiscal year July 1, 1986, through June 30, 1987.

Section 8. That \$749,592 is appropriated to the Central Kenai Peninsula Road Maintenance Service Area fund for operations

Section 9. That \$424,490 is appropriated to the South Kenai Peninsula Road Maintenance Service Area fund for operations for the fiscal year July 1, 1986, through June 30, 1987.

Section 10. That \$259,167 is appropriated to the North Kenai Peninsula Road Maintenance Service Area fund for operations for the fiscal year July 1, 1986, through June 30, 1987.


Section 11. That \$889,977 is appropriated to the Central Peninsula Emergency Medical Service Area fund for operations for the fiscal year July 1, 1986, through June 30, 1987.

Section 12. That \$105,530 is appropriated to the Anchor Point Fire and Emergency Medical Service Area fund for operations for the fiscal year July 1, 1986, through June 30, 1987.


