**KENAI PENINSULA BOROUGH**

**ORDINANCE 86-57  
(SUBSTITUTE)**

APPROPRIATING STATE GRANT FUNDS TO PROJECT ACCOUNTS FOR GRANTS RECEIVED FROM THE STATE OF ALASKA TOTALING \$421,250 MADE BY CHAPTER 128, SESSION LAWS OF ALASKA 1986, AND REPEALING ORDINANCE 86-48 (SUBSTITUTE).

WHEREAS, the State of Alaska has notified the Kenai Peninsula Borough that the sum of \$421,250 has been appropriated for grants to the Borough by Chapter 128, SLA 1986 for the development of specific capital projects; and

WHEREAS, the Kenai Peninsula Borough has accepted receipt of those grant funds through Resolution 86-105; and

WHEREAS, the monies appropriated under Ordinance 86-48 (Substitute) has been reduced; and

WHEREAS, it is necessary to appropriate those grant funds to the specific project accounts;

NOW THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. That the sum of \$103,250 is hereby appropriated from the Road Capital Project Fund to the Alternate Emergency Escape Route Nikiski, account no. 418-331032-49999-87403.

Section 2. That the sum of \$24,000 is hereby appropriated from the Nikiski Fire Service Area Capital Projects Fund to the project Nikiski Fire Hall Improvements, account no. 441-511010-49999-87404.

Section 3. That appropriations are made from the Kalifornsky Beach Fire Service Area Operating Fund for the Kalifornsky Beach Fire Service Area Equipment, account no. 210-515010-49999-87405, in the amount of \$45,000.

Section 4. That appropriations are made from the Ridgeway/Sterling Fire Service Area Capital Fund for the project Ridgeway/Sterling Fire Service Area Equipment and Construction, account no. 443-513010-49999-87406, in the amount of \$25,000.

Section 5. That Ordinance 86-48 (Substitute) is repealed. That the sum of \$224,000 is hereby appropriated from the Road Capital project fund to the Robinson Loop Road account no. 418-331023-49999-87408.
