KENAI PENINSULA BOROUGH

ORDINANCE 86-59

ACCEPTING GRANTS FROM THE STATE OF ALASKA AND THE U. S. DEPARTMENT OF COMMERCE TO FORMULATE THE CHUITNA AREA RESOURCE DEVELOPMENT PLAN.

WHEREAS, the Kenai Peninsula Borough Assembly requested the administration formulate a comprehensive plan for the west side of Cook Inlet in Resolution 85-168; and

WHEREAS, the administration has developed an approved scope of work for the Chuitna area resource development plan to obtain funding for the project; and

WHEREAS, the following agencies have allocated funds to aid in the development of the Chuitna area plan: the State of Alaska Department of Transportation and Public Facilities (\$57,000), the State of Alaska Department of Commerce (\$10,000), and the U. S. Department of Commerce (\$20,000); and

WHEREAS, the Chuitna area plan will serve as a guide for future policy and investment on the west side of the Cook Inlet;

NOW THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. That the assembly hereby accepts a grant of \$57,000 from the Alaska Department of Transportation and Public Facilities, of \$10,000 from the Alaska Department of Commerce, and of \$20,000 from the U. S. Department of Commerce.

Section 2. That the Borough's matching monies in the total amount of \$41,100 are hereby appropriated from the Land Trust Fund unappropriated fund balance.

Section 3. That the expenditure of funds appropriated by this ordinance shall be returned to the Land Trust Fund of the Borough from the proceeds of the sale of the port revenue bonds after the port revenue bond issue is funded.

Section 4. That the sum of \$128,100 is hereby appropriated to the following accounts in these respective amounts:
