KENAI PENINSULA BOROUGH

ORDINANCE 86-72

PROVIDING FOR AN ELECTED BOARD FOR THE CENTRAL KENAI PENINSULA HOSPITAL SERVICE AREA AND RATIFICATION OF THIS ORDINANCE BY THE VOTERS.

WHEREAS, the Central Kenai Peninsula Hospital Service Area Board is an appointed board; and

WHEREAS, all of the service area boards in the Borough are elected; and

WHEREAS, the assembly wishes to allow the voters within the service area to have a choice as to whether they wish an elected or an appointed board;

NOW THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. That KPB 16.08.020 is hereby amended to read as follows:

16.08.020 Board-Established-Membership. There is established a [HOSPITAL] board for the Central Kenai Peninsula Hospital Service Area composed of 9 members. [WHO SHALL BE NOMINATED BY THE BOROUGH MAYOR AND APPOINTED BY THE ASSEMBLY.]

Section 2. That KPB 16.08.030 is hereby amended to read as follows:

16.08.030 Board-Qualifications-Terms of office-Vacancy filling. A. Members of the board shall be qualified voters of the Borough who are residents of the service area. Members shall be elected [APPOINTED] for a term of three (3) years. [,EXCEPT THAT THE FIRST BOARD SHALL CONTAIN MEMBERS APPOINTED FOR LESSER PERIODS TO PROVIDE FOR STAGGERED TERMS. VACANCIES ON THE BOARD SHALL BE CREATED AND SHALL BE DECLARED BY THE ASSEMBLY IN ACCORDANCE WITH AS 29.23.570.] Vacancies on the board may be declared in accordance with Borough ordinances and for the reasons contained in Title 29 of the Alaska Statutes governing vacancies for assembly seats.

B. Initial elected terms: The terms of appointment for existing appointed board members sitting as of October 1, 1986 shall continue until the expiration of

the term without election. Upon end of a term of a current appointed board member or the next election following a vacant seat being filled by appointment, the seat shall be filled by election of a board member. Should the term of an appointed member sitting as of October 1, 1986 expire at a time other than the date of a regular election, that member's term shall be extended until the date of the next regular municipal election.

Section 3. That an election shall be held at the next general election to submit this issue to the voters for ratification of this ordinance pertaining to an elected board.

Section 4. That Sections 1 and 2 of this ordinance are effective only upon ratification of this ordinance by the voters of the service area at the next regular municipal election. All other sections of this ordinance shall be effective immediately.
