KENAI PENINSULA BOROUGH

ORDINANCE 86-89

ACCEPTING A \$6,500 INCREASE TO A GRANT FROM THE STATE OF ALASKA FOR CONTINUATION OF THE COASTAL MANAGEMENT PROGRAM AND AMENDING THE GRANT BUDGET.

WHEREAS, the Kenai Peninsula Borough has accepted a \$45,000 grant from the State of Alaska, Department of Community and Regional Affairs and appropriated a \$4,500 match through Ordinances 85-74 and 86-42; and

WHEREAS, a \$6,500 grant increase was awarded to the Kenai Peninsula Borough; and

WHEREAS, coastal related planning projects previously approved as part of the contract services portion of the Borough 1986-87 budget have been completed to expend these funds;

NOW THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. That Ordinances 85-74 and 86-42 are amended to include the \$6,500 grant increase.

Section 2. That the \$6,500 grant shall be appropriated to reimburse account 100-211010;

Section 3. That the Borough's 10% matching monies in the total amount of \$650 are hereby appropriated from Coastal Zone Management fund balance (257-27900)

Section 4. That the grant project budget is amended as follows:
