- Section 2. That \$88,662 is appropriated to the Bear Creek Fire Service Area fund for operations for the fiscal year July 1, 1987, through June 30, 1988.
- Section 3. That \$797,780 is appropriated to the Ridgeway/ Sterling Fire Service Area fund for operations for the fiscal year July 1, 1987, through June 30, 1988.
- Section 4. That \$112,224 is appropriated to the Anchor Point Fire and Emergency Medical Service Area fund for operations for the fiscal year July 1, 1987, through June 30, 1988.
- Section 5. That \$428,510 is appropriated to the Kalifornsky Fire Service Area fund for operations for the fiscal year July 1, 1987, through June 30, 1988.
