ORDINANCE 87-35 (CORRECTED)

ACCEPTING AND APPROPRIATING GRANTS FROM THE U. S. DEPARTMENT OF COMMERCE AND THE STATE OF ALASKA TO UPDATE THE BOROUGH OVERALL ECONOMIC DEVELOPMENT PROGRAM AND EXAMINE THE FORMULATION OF AN ECONOMIC DEVELOPMENT DISTRICT.

WHEREAS, the Kenai Peninsula Borough Assembly has in Ordinance 86-92 outlined an economic development program; and

WHEREAS, the administration has developed a scope of work to obtain funding for the overall economic development program and the formulation of an economic development district; and

WHEREAS, the U.S. Department of Commerce has awarded a grant of \$60,000 for this program; and

WHEREAS, the economic development program will serve as a guide for future economic development activity in the Kenai Peninsula Borough;

NOW THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. That the assembly hereby accepts grants from the U. S. Department of Commerce for \$60,000.

Section 2. That \$20,000 from the Kenai Peninsula Borough Economic Development Division in the Resource Planning Department will be used as a match and transferred to the grant account.

Section 3. That the sum of \$80,000 is hereby appropriated to the following accounts in these respective amounts:
