KENAI PENINSULA BOROUGH

ORDINANCE 87-42

DECLARING FOUR PORTABLE CLASSROOMS AS SURPLUS, AUTHORIZING THE TRANSFER OF ONE SURPLUS PORTABLE CLASSROOM TO HOMER SENIOR CITIZENS, INC. FOR USE AS AN ADULT DAY CARE CENTER IN HOMER, AUTHORIZING THE TRANSFER OF TWO SURPLUS PORTABLE CLASSROOMS TO THE LOCAL AGENCIES OF THE UNIVERSITY OF ALASKA; AND PROVIDING FOR THE TRANSFER OF ONE SURPLUS PORTABLE CLASSROOM BY LOTTERY.

WHEREAS, the Kenai Peninsula Borough School District has declared four portable classrooms at Kalifornsky Beach Elementary School surplus to its needs; and

WHEREAS, Homer Senior Citizens, Inc. has requested that the borough donate one of the portable classrooms to their organization for use as an adult day care center in Homer; and

WHEREAS, the City of Homer has agreed to provide a city lot to be used for operation of the adult day care center; and

WHEREAS, after being notified of the availability, no other senior citizen group on the Peninsula has expressed a desire to obtain one of these portables; and

WHEREAS, agencies of the University of Alaska have requested the donation of portable classrooms for use by the Kenai Peninsula College and the Mining and Petroleum Training Service; and

WHEREAS, other civic, non-profit, and educational groups on the peninsula have expressed their desire to obtain these units;

NOW THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. That the four portable classrooms at Kalifornsky Beach Elementary School be declared surplus.

Section 2. That the borough hereby transfers to Homer Senior Citizens, Inc. one of their choice of the four surplus portable classrooms.

Section 3. That the Borough hereby transfers to the local agencies of the University of Alaska, Kenai Peninsula College and the Mining and Petroleum Training Service, two surplus portable classrooms, of their choice, provided that selection be made and notice given to the Borough within ten days of the effective date of this ordinance.

Section 4. That the remaining surplus portable classroom be transferred to other civic, non-profit, or education groups by means of a lottery as specified in the attachment to this ordinance entitled "Lottery for Disposal of Surplus Portable Classrooms."

Section 5. That as a condition of the transfer of these surplus portable classrooms, each group receiving a portable will provide for removal of the portable from the school site during a Saturday or Sunday under the direction of Kenai Peninsula Borough personnel and will be responsible for all expenses and necessary permits required for movement of that portable classroom.

Section 6. That a fee of \$500 per each unit will be charged by the Borough to each group receiving the portables for the purpose of providing borough personnel required for the preparation and disconnection and for supervision of the removal of the portables from the school grounds.

Section 7. That the groups receiving these portables will be required to move the portables from the school grounds by midnight, October 25, 1987.


Section 8. That any portables remaining on October 26, 1987, will be sold in accordance with Chapter 5.28.500(B) of the Procurement and Purchasing Procedures without further action by the Assembly.

Section 9. That this ordinance takes effect immediately upon its enactment.
