ORDINANCE 87-64

APPROPRIATING AND TRANSFERRING CENTRAL KENAI PENINSULA HOSPITAL SERVICE AREA FUNDS TO PROVIDE THE NECESSARY RESERVES FOR THE INDEMNITY AGREEMENT BETWEEN THE SERVICE AREA AND EMERGENCY ROOM PHYSICIANS.

WHEREAS, Resolution 87-94 Substitute authorized an indemnity agreement between the Central Kenai Peninsula Hospital Service Area and the emergency room physicians; and

WHEREAS, under that agreement, up to \$400,000 could be provided for indemnity of physicians in connection with malpractice claims brought against them; and

WHEREAS, Resolution 87-94 approved the agreement and encumbered \$100,000 of the \$400,000 that should be reserved; and

WHEREAS, an additional \$300,000 should be appropriated and the already encumbered \$100,000 should be transferred to a reserve account for this purpose;

NOW THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

- Section 1. That \$300,000 be appropriated from the fund balance of the Central Kenai Peninsula Hospital Service Area to account number 600.811010.47700 Transfer to Insurance and Litigation Fund and transferred to the Insurance and Litigation Fund.
- Section 2. That \$100,000 from the Central Kenai Peninsula Hospital Service Area operating subsidy account number 600.811010.43980 be transferred to account number 600.811010.47700 Transfer to Insurance and Litigation Fund and transferred to the Insurance and Litigation Fund.
- Section 3. That \$400,000 be reserved in the Insurance and Litigation fund account number 700.27901 Reserve for CPGH Indemnity for obligations pursuant to the indemnity agreement authorized by Resolution 87-94.
- Section 4. That balances from this account not expended pursuant to the indemnity agreement shall refert to the Central Kenai Peninsula Hospital Service Area operating fund upon termination of the indemnity agreement or obligations arising from it.
